# Big 'No' to service delivery Barabbas mentality: Minister Garwe

OCAL Government and Public Works minister Daniel Garwe has implored Chitungwiza residents to reject the Barabbas mentality when making service delivery decisions and warned those illegally dumping garbage that the government was crafting a law that will make littering an offense punishable by imprisonment.

Garwe said this yesterday when he officiated at the launch of Operation Chenesa 2 at Chigovanyika Shopping Centre in St Marys, Chitungwiza.

The operation is set to restore cleanliness in Chitungwiza which has put residents' lives at risk by failing to provide basic services including perennial sewer challenges and garbage collection.

"We are not only going to impose fines, but we will pay a fine and also go to jail this will make people living in sanitises the environments "In places that we visit be it in China, Japan us or UK you don't throw litter everywhere because you will be

Garwe said Chenesa 2 was the last such operation and urged residents to have a Chenesa 3 mindset that beginning by cleaning up their thoughts in order to clean up the environment you live in.

"Pontius Pilate was obligated to select one person who the people would decide to be freed when he was making judgments on who to sentence to death by hanging.

"Pilate asked the people to make a choice on who to forgive between the king of Nazareth Jesus and Barabbas the notorious thief.


the corruption-ridden municipality, in a move that also reduces his chances of becoming the substantive town clerk.

the Public Works committee to ensure that the engineering department resolves the sewer challenges bedeviling the town.

In response, Public Works committee chair Councillor Musa Makweza did not mince his words while issuing a warning to Nemuseso to either reign in his errant management team, most of whom are also in acting positions, or face the axe as acting town clerk.

"From now onwards if your managers continue to fail to implement our resolutions I will personally propose for your removal from that chair so that there is someone else who will be able to supervise those people.

"Because I can't hide the truth, if you see your managers failing to implement (resolutions), then we have nothing to do with those managers, we will deal with you accordingly."

"Because we can't keep on saying the same thing and going backwards due to your failure to supervise your management, we have passed many resolutions, if people are not respecting them, you rotate them, but you are comfortable with the situation.

"If you are comfortable with the situation its okay, but to tell you the truth, if these resolutions are not implemented I will personally move a motion" Cllr Makweza said.

Nemuseso, who was appointed the town's chamber secretary and later assumed the role of acting town clerk in line with the Urban Council's act, is reported to be vying for the position of town clerk.

Chitungwiza has been without a substantive town clerk for five years following the suspension in September 2019 of Dr George Makunde who was later dismissed in June 2021 under controver-

HE lack of adequate and continuous water supply is the major cause of Chitungwiza's perennial sanitation problems that is underscored by frequent sewage outflows and recurring sewage pipe bursts.

Councillor Watmore Muchairi revealed during last week's full council meeting that perennial bursting of pipes and outflows of raw sewage in the third most urban populated city in Zimbabwe were due to old and strained water and sewer infrastructure capacity.

"Our sewer pipes are very old. As for the challenges we are facing, I am sure that everyone in this chamber understands that sewer and water work hand in glove. As long as we don't have water I don't think we will overcome that issue.

"Because each sewer line is designed if you see 100mm diameter 5, 150mm diameter pipe, 300mm diameter 5, 450mm diameter trunk and so on and so forth it have water that it must contain to give it what is called self-cleansing velocity that will make it clean itself on its own

Cllr Muchairi added that sewer system is under strain due to siltation.

"This is causing an increase in siltation in our lines which are also rotten. That is why that company failed because of siltation and there was no adequate or continuous flow of water.

"Let's not think that the engineering department has failed to do its job yet we have a big elephant in the room that we should also need to look into.

"That's why we are seeking all these investors it's because we want them to address the issue of water to solve the perennial sewer problems"

Muchairi likened the recent work by council of upgrading trunk lines to that of building septic tanks.

"If we finish work on the trunk line as long as we don't have continuous flow of water it will accumulate silt and cause blockages again

"If we are to look at the monthly report from public works since January they are clocking more than 1 000 blockages a month then we disappoint them saying they are not working people

He added that the sewer pipes are dilapidated and laden with silt resulting in a recurrence of bursts.

Chitungwiza faces the perennial challenge of poor water supply, sanitation and hygiene (WASH) service delivery.

Its sewerage infrastructure is overwhelmed, resulting in overspills of effluent.

# Navigating difficult waters: addressing Africa's water scarcity challenges through PPPs

Water scarcity poses a significant challenge to sustainable development and the well-being of people across the Africa and with factors such as a burgeoning population, changing climate patterns, infrastructural gaps, and uneven distribution of resources, the continent is grappling with the tangible consequences of restricted access to clean and safe water sources

According to the 2023 Global Water Security Assessment by the UN, more than 1.3 billion people in Africa face water insecurity, with 13 countries being critically water insecure.

Sub-Saharan Africa, as of 2019, reflects a concerning scenario where only 56% of urban residents have access to piped water (down from 67% in 2003), and a mere 11% have a sewer connection.

Addressing water scarcity requires strategic investments in modern water infrastructure, the adoption of climate-resilient agricultural practices, and active community engagement. Governments and international organisations must prioritise efficient water resource management systems, such as dams, wastewater treatment and reuse facilities, and desalination facilities. To reduce the financial burden on state-owned water utilities and improve operational efficiencies, governments can adopt the Public Private Partnership (PPP) model for the improvement of water infrastructure. And there have been demonstrated success stories for the same:

- Wastewater treatment plants (WTP):
   Wastewater treatment plants are an absolute necessity in the industrialised world.
   They reduce the pollution of already scarce freshwater resources, and the treated water can be used for irrigation and industrial uses and even for drinking after further treatment, reducing the stress on natural sources. The PPP model in WTP was first introduced to Africa in 1999 with a WTP in Durban, South Africa, and the success was later replicated in New Cairo, Egypt in 2009.
   Water desalination plants: For places with
- little to no fresh water and an abundance of sea/brackish water, Water desalination plants offer a good value proposition. Globally, more than 300 million people get water

- from water desalination plants. For instance, Algeria successfully implemented the PPP model for its Water Desalination Program and brought international experience and funding into the country.
- Water pipeline projects: Water transfer projects include any type of infrastructure that transfers water from any freshwater body to a place where it will be utilised by humans. With water resources spread unevenly across the continent, water transfer projects will not only improve clean water access but also bring economic development on the back of Industrial growth.

#### Water PPP projects underway

As the continent navigates these challenges, numerous PPP projects are underway, offering hope for a more sustainable future. Examples include the following projects:

- 6th October City West Phase 3 in Egypt, SoQs are expected in Q1 2024.
- The Chobe-Zambezi water transfer and Glen Valley water reclamation plant in Botswana, RFQ is expected in Q1 2024.
- uMdloti and uMkhomazi WWTP in South Africa, RFP expected in Q1 2024.
- Nador SWRO in Morocco, RFP expected in H1 2024.

These initiatives signify a collective effort to alleviate water scarcity and foster resilience, emphasising the importance of a holistic approach to secure a water-secure future for Africa.
